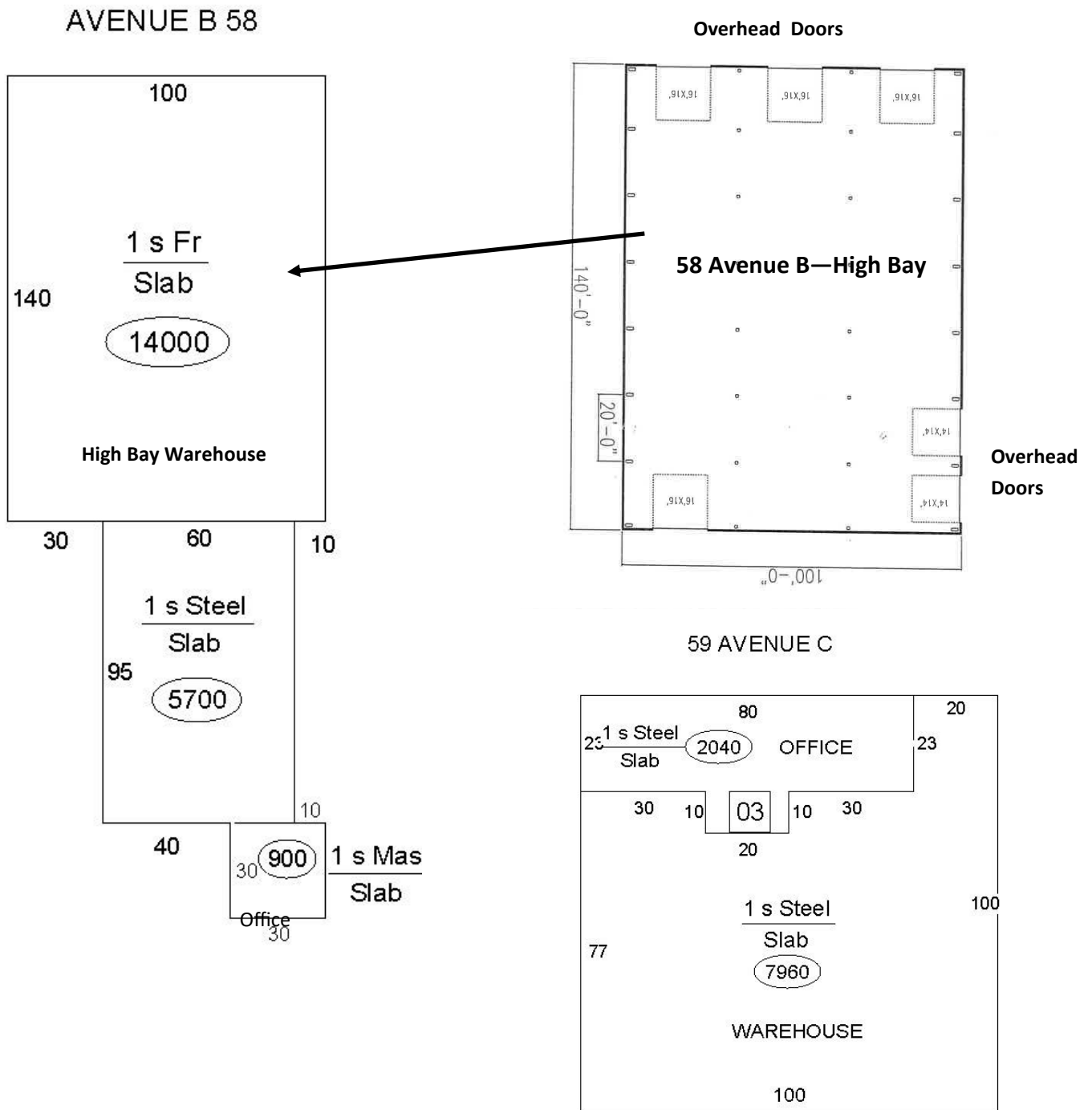

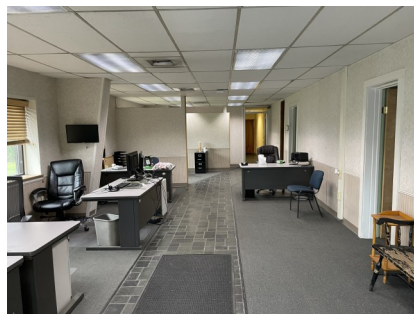

#### RIGHT NOW YOU ARE NOT A CLIENT

#### You May Become a Client
